

COOKIE POLICY

The given Up2 Money Website ("Website") contains cookies. Any data provided to or collected by Up2 Money Website via cookies is controlled by Up2 Money. This Cookie Policy may be changed from time to time with the relevant notice on the Website for us to be compliant with the legislation and/or generally accepted practices relating to cookies, also when our cookie practices change.

Up2 Money uses cookies to improve user experience, make the Website work, enable site security, and provide the business with marketing information about the Website's visitors ("you"). A cookie is a small text file that is stored on the hard disk of the visitors' device by the Website. The cookie text files comprise numbers and letters. The cookie files are saved into special areas in the memory of your computer or mobile device. Cookies allow the Website to recognise the visitors' devices. Different cookies can have many different functionalities, but the most common ones are usually used for enabling different functionalities of the Website (strictly necessary cookies), gathering statistics on the usages of the Website, and advertising purposes. UP2 MONEY CLASSIFIES COOKIES THAT IT USES ON THE WEBSITE AS FOLLOWS:

Strictly Necessary Cookies

These cookies are set by the Website you're visiting and only that Website can read them. Up2 Money's cookies are "first-party cookies". This means that these are cookies set by our Website and our sister domain names. These cookies are required for you to access and use the Website and for us to monitor the use of them. We do not share any of your data collected by these cookies with any third parties.

Please note that Up2 Money's cookies are essential for you to fully use our Website and application process and enable us to offer you our services. If you do not accept these cookies, then you may not be able to access or use some of the Website's functionalities, nor will we be able to provide you with our services.

Third-party cookies

These cookies are set by someone other than the owner of the Website you're visiting. Third-party cookies on the Website are presented by companies with whom we work as part of our marketing initiatives. The third-party cookies that we use and the purpose thereof can be seen in the table below. Up2 Money has no control over third-party cookies. Third parties should be contacted directly to view their cookie privacy information and settings.

Whilst the third-party cookies do collect your data, we have endeavoured to ensure that the information they collect is anonymised.

Performance cookies

These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our site, and will not be able to monitor its performance.

Functional cookies

These cookies enable the Website to provide enhanced functionality and personalisation. They may be set by us or by third-party providers whose services we have added to our pages. If you do not allow these cookies then some or all of these services may not function properly.



Targeting cookies

These cookies may be set through our site by our advertising partners. They may be used by those companies to build a profile of your interests and show you relevant adverts on other sites. They do not store directly personal information but are based on uniquely identifying your browser and internet device. If you do not allow these cookies, you will experience less targeted advertising.

Social media cookies

These cookies are set by a range of social media services that we have added to the site to enable you to share our content with your friends and networks. They are capable of tracking your browser across other sites and building up a profile of your interests. This may impact the content and messages you see on other Websites you visit. If you do not allow these cookies you may not be able to use or see these sharing tools.

Lawful basis for processing

We ask for your consent before we load any third-party cookies or cookies that are not strictly necessary into your browser or device. Strictly necessary cookies are essential to enable you to use the full functionalities of our Website and therefore we are not required to collect your consent before using them. However, you are free to set your browser settings not to accept any cookies from the Website, including strictly necessary ones, but this will exclude your access to some functionalities and services provided on our Website. Up2 Money may use time to time other tracking technologies which allow us to measure the audience on our Websites. Such tracking technology's purpose is strictly limited to the sole measurement of the audience of the site or the applications (performance measurement, detection of navigation problems, optimization of technical performance or its ergonomics, estimation of the power of the necessary servers, analysis of content). Data gathered for this purpose is not shared with any third parties.

Cookie preferences

If you do not want to accept cookies, you can set your browser to automatically disable them or to inform you on each occasion when a Website is requesting to add a cookie. Please refer to your web browser's help function to make the necessary settings.
